We have completed our investigation of the liquor license renewal for Joey Nova's Pizzeria Delicatessen. We have checked PC Enfors (internal record system), State of Minnesota and NCIC warrant files, Jail Records, Odyssey (court records), State of Minnesota criminal history files, Minnesota Alcohol and Gambling Enforcement Division, Secretary of State and local jurisdiction (if applicable). Unless noted below, there were no disclosable records for convictions within the past five years of any violation of laws of the State of Minnesota or city ordinances relating to intoxicating liquor.

It should be noted Joey Nova's lists a new owner for this background check. The new owner lists another establishment in Edina he has owned for the past 22 years. The Edina Police Department was contacted for any violations involving that establishment. Their response is listed under Joey Nova's results.

Due to regulations on the dissemination of criminal history information, we can not access nationwide criminal history files for the purpose of background liquor license checks.
